## Instructions for All India Quota candidates coming for counselling / Admission for the academic session 2021-22 (via [www.aaccc.gov.in](http://www.aaccc.gov.in))

1. Before entry to the state of Meghalaya all allotted candidates have to comply with the prescribed rules and regulations issued by Govt. of Meghalaya on COVID-19 (Please check <http://meghalayaonline.gov.in/covid/test.htm>).
2. COVID-19 Test Report alongwith vaccination certificate are to be produced as and when asked for by NEIAH authorities on entering the Institute's premises.
3. All allotted candidates have to produce allotment letter alongwith following documents in original at the time of reporting admission -
  - a) NEET Admit Card (Original)
  - b) NEET mark-sheet (Photocopy)
  - c) Medical fitness certificate issued by registered medical practitioner in prescribed format as attached in Annexure - VI in FAQs tab at [www.aaccc.gov.in](http://www.aaccc.gov.in).
  - d) 10th Mark-sheet
  - e) 12th Mark-sheet
  - f) 12th pass certificate
  - g) Domicile / Permanent Residential Certificate (PRC) from Competent Authority (DC Office)
  - h) Caste Certificate (All allotted OBC candidates have to produce latest OBC NCL certificate)
  - i) Transfer certificate
  - j) Migration Certificate
  - k) Gap Certificate (If) etc.
4. 04 (four) nos. of Bond on non-judicial stamp paper of Rs 10/- each duly signed and dated are to be submitted at the time of reporting / admission. (Format as in Annexure III, IV, V & VI is enclosed).
5. Presently there is no hostel facilities for students in the Institute. Students who get admitted have to arrange their accommodation on their own.
6. Admission fee is to be submitted through Bank challan only (Bank Challan format will be provided by Institute).
7. Classes for first year BAMS & BHMS (Session -2021-22) will commence from 11<sup>th</sup> April, 2022 from 09.00 am onwards (Attendance is compulsory).
